CALPAC Committee Meeting Minutes Monday 22nd January 2024

Microsoft Teams Meeting opened at 7pm by Dean Hawkins

Online Attendees

Removing and Updating Trustees for Property Matters owned and leased by CALPAC.

Due to the very sad loss of John Bygrave and Malcolm Corner, we have consulted the firm of solicitors Calpac used last, to discuss the procedure to update the trustees for Burgh Hill lease on Manor Pond as well as the three registered titles and first registration of Padworth.

Currently Ray Wilkinson is the only trustee on land registry and David Adby is the only trustee we have registered with Burgh Hill and they require two trustees to sign the lease. We are proposing that Carmel Jones, Dean Hawkins and Denise Wheeler are appointed as new trustees for both Burgh Hill Lease and all four fisheries, whilst also removing Raymond Wilkinson as a trustee.

The CALPAC Constitution sets out the procedure that must be followed in order to arrange Raymond Wilkinson's resignation as a trustee and the appointment of Carmel, Dean and Denise as new trustees. The Constitution prescribes that appointment is endorsed by resolution of the Committee and confirmed in a Deed of Appointment executed by the President of the Association (with whom the power of appointment under the Trustee Act 1925 sits). Pursuant to this appointment, legal title to any land, rights and other assets of CALPAC will automatically vest in the names of the new trustees and they will have authority to deal with property matters.

Outcome

All in attendance agreed for Carmel Jones, Dean Hawkins and Denise Wheeler to be appointed Trustees and the process for resignation of Raymond Wilkinson as a trustee to be started officially by the solicitor.

It was agreed that before any paperwork is sent to Ray Wilkinson, a letter on behalf of all the committee will be sent to Ray explaining what has been agreed as well as thanking him for

David Blake offered to be a trustee if required in future.

Committee Members

Again due to the loss of key committee members, Alf John and Malcom we need to adhere to constitution and fill vacant positions, which is normally formally addressed at the AGM. Due to the exceptional circumstances it was agreed that we would discuss, propose /second indivuduals now and review and confirm again at the AGM.

Dean proposed George McKee (Bailiff at Manor Pond) and Alex Gardner (Bailiff at The Mole) to become General Committee members, seconded by Denise Wheeler and agreed by all in attendance.

Dean Hawkins proposed Jim Hamilton as Prseident and seconded by Carmel Jones.

Carmel Jones proposed Denise Wheeler as Vice President which was seconded by David Blake.

Dean Hawkins proposed David Blake as Chairman which was seconded by Denise Wheeler.

Denise Wheeler proposed Carmel Jones as Treasurer which was seconded by David Blake.

- All in attendance agreed to the above appointments.
- Dave Blake did mention it could be done as a EGM, however Phil Oakeshott said that this meeting is not a Emergency <u>General</u> Meeting.
- Phil Oakeshott asked if affilated clubs, automatically have a member on the Calpac committee, consenious was no.
